**No.191/2 G & T/2007** whereas , “The Right to Information Act, 2005 “ (Act 22 of 2005) has been enacted by the Parliament & has received the assent of the President of India on 15<sup>th</sup> June, 2005 and has been published in the Gazette of India by the Ministry of Law and Justice (Legislative Department) on 21<sup>st</sup> June, 2005.

The Right of Information Act, 2005 is an Act to provide for setting out the practical regime of right to information for citizens to secure access to information under the control of public authorities, in order to promote transparency and accountability in the working of every public authority and for matters connected therewith or incidental there to.
