EXTRACTS OF E-MAIL DATED 4th AUG 2011, 17:00:23 FROM FCPS/IRRIGATION TO ALL EIC/CEs/SEs

Dear SEs/Xens

While reviewing the progress of e-tendering, it has been brought to my notice that no tender for value of work Rs 5.00 lacs is to be allotted unless process of e-tendering is adopted. Kindly confirm the same in respect of tenders under your charge starting from 1st April, 2011.

Henceforth this should be considered an order of the Govt that allocation of work more than Rs 5.00 lacs can only be done after adopting e-tendering. In case any other process except e-tendering is adopted, special permission of the Chief Engineer concerned will have to be obtained in writing. The Chief Engineer concerned may give such permission but he will inform the XEN in-charge of e-tendering at the headquarters regarding such permission.

SEs & XENs are also requested to bring to my notice any problem which they are experiencing in adoption of such a process.

Record of decisions taken in the meeting held on 06/09/2011 regarding e-tendering and e-monitoring.

- (i) Monthly information be sent regarding tenders of value of more than 5.00 lacs without following the procedure of e-tendering.
- (ii) It was noted that HKB Jagadhari Circle was not calling the e-tenders as the tenders were also being called manually. The concerned officers should be charge-sheeted regarding this lapse. The Chief Engineer be asked as to why the permission has been granted for both manual and on line tenders.
- (iii) The bidders must upload the scanned copy of the EMD and cost of the document and if he does not submit the same upto the time of opening, he should be blacklisted for one year.
- (iv) It has been seen that XENs are not sending emails to all the contractors regarding tenders being opened in their division. This is against the instructions. CE must ensure before approval of the tenders that has been done.
- (v) There are issues of connectivity in a few divisions. In those divisions, the Divisional Officers can use the data card wherever applicable and they should then send the email regarding the same with a copy to FC&PS (Irrigation) with reasons.

(vi) All the instructions should be put on the departmental web site.

(vii) In case of HKB Circle, Jagadhari and SYL Circle Ambala, no manual tenders without the express approval EIC will be accepted. Chief Engineer will not have any power of granting exemption in these cases.
