


The above offer is subject to the following terms and conditions:-

1. You are declared medically fit for Government service by the Chief Medical Officer. You should appear before the concerned C.M.O. of your district immediately for medical examination & to get the Medical Certificate of Fitness which you will have to submit in this office at the time of joining.
2. You will be on probation for a period of two years from the date of joining. The probation period can be extended for another one year. In case, your work and conduct are not found satisfactory during the probation period, your services will be liable to be terminated without giving any notice or pay in lieu thereof.
3. This appointment is purely provisional (temporary). This post is liable to be abolished at any time and carries, no promise of subsequent permanent employment. The confirmation will be made as per Rules & Government instructions. Therefore, it is made clear to you that in case any adverse facts come to the notice of the Government regarding your character and antecedents, your services are liable to be terminated immediately without giving any notice and without prejudice to such further action as may be taken under provision of the Indian Penal Code for production of false certificates/ statements/ documents.
7. That in case you are married, you have only one living spouse and you are not married to a person who has more than one living spouse. If you have more than one living spouse, you should justify the circumstances for that. 8. That you will not undertake higher studies of any kind, without obtaining the prior permission. Consequently, no leave of any kind will be granted for pursuing higher studies.
9. You will be governed by the "New Defined Contribution Pension Scheme" as per Haryana Govt. Finance Deptt. Notification No.1/1/2004-1Pension dated 28.10.2005.
10. Your services can be utilized anywhere in the State/Country including Bhakra and Beas Projects or any other projects outside the State in which Haryana State is interested.
11. Your original certificates regarding educational qualification, age, caste/ category, domicile etc. will be got checked/ verified from the issuing authorities. If any document is found false/fictitious, your services will be terminated without assigning any further reasons and without prejudice to such further action as may be taken under the provision

of the Indian Penal Code for production of false certificate. In this regard, **you will have to submit self-declaration by way of affidavit duly attested by Notary Public to your controlling officer within a period of one week after allotment of place of posting.**

12. In case of SC/ST/BC (A&B)/EBPGC/OSP candidate the appointment is provisional and subject to the SC/ST/BC (A&B)/EBPGC/OSP certificate being verified through proper channel and if the verification reveals at any stage that the claim belonging to SC/ST/BC(A&B)/EBPGC/OSP, as the case may be, is false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provision of the Indian Penal Code for production of false certificate.
13. In case you are employed in Government/Semi Government office, you should either bring No Objection Certificate from your present employer or the letter of acceptance of your resignation by such department/organization before submitting arrival report to this department.
14. Your pay will commence from the day you actually join the department.
15. No travelling allowance will be admissible for joining this post.
16. Since the work of the department is done on computer in view of the modernization of technology, you will have to work on computers also.
17. **This offer is subject to the final outcome of CWPs, if any, pending in Hon'ble High Court.**






