**Subject:** Minutes of Meeting of enlistment Committee to discuss the debarring case of the "The Jagrambass Co-op Society Ltd. Bhiwani" and blacklisting case of M/S Shree Balaji Builders, H. No. 858-P, Sector-23, HUDA, Bhiwani & M/S Laxmi Construction Co., Vidya Nagar, Meham Road, Bhiwani.


**Reference:** Your office U.O No. 1509/9G dated 10.07.2018 , letter No. 1715-17/2A/NNL dated: 09.08.2018 and No. 1708-10/2A/NNL dated: 09.08.2018.

Vide above said references, your office has recommended the debarring case of the "The Jagrambass Co-op Society Ltd. Bhiwani" and blacklisting case of M/S Shree Balaji Builders, H. No. 858-P, Sector-23, HUDA, Bhiwani & M/S Laxmi Construction Co., Vidya Nagar, Meham Road, Bhiwani.

Accordingly, a meeting of Enlistment Committee of Irrigation & Water Resources Department, Haryana were held on 10.08.2018, 04.09.2018 & 31.10.2018 to discuss above said cases. The opportunity was given to the concerned contractor represent their cases in the presence of concerned Superintending Engineer and Executive Engineer. The minutes of the last meeting held on 31.10.2018 is enclosed herewith for further necessary action accordingly. The following decision was taken by the enlistment Committee:-

M/S Laxmi Construction Co., Vidya Nagar, Meham Road, Bhiwani	Debarred from participating in the tenders process of I&WRD for a period of 12 months from issue of orders i.e. upto 12.11.2019.

**Minutes of Meeting of Enlistment Committee to discuss the debarring case of "The Jagrambass Co-op Society" and blacklisting case of M/S Laxmi Construction Co. & M/S Shree Balaji Builders held on 31.10.2018.**

The meeting of Enlistment Committee to discuss the case of debarring of "The Jagrambass Co-op Society" and blacklisting case of M/S Laxmi Construction Co. & M/S Shree Balaji Builders was held on 31.10.2018 under the chairmanship of Chief Engineer/Project-cum-Chairman Enlistment Committee.

The case wise details of the facts and the decision taken are as under:

**1. Debarring case of "The Jagrambass Co-op Society Ltd." Bhiwani:**

In the previous meeting held on 10.08.2018, the president of the above said society Sh. Chhater Singh has informed the Committee vide his written statement that his society had participated in the tender for pipeline projects of Nolpur Disty. & Hassanpur Disty. through online tendering. But while submitting the physical tender fee through DD, the original DD of tender fee was misplaced and agency could not submit the original DD before the last date. He has further regretted that this mistake would not be repeated and humbly requested for not debar the society. SE, JLN Circle Narnaul and Xen, Narnaul W.S. Division, Narnaul were also present and apprise the committee that the contractor has submitted the bid documents online but not submitted the original drafts of the tender fees. After hearing the president, SE, JLN Circle Narnaul and Xen, Narnaul W.S. Division, Narnaul committee has decided to refer back the case to the concerned SE for verification of the facts narrated by the agency and send report to the committee with his comments/recommendation accordingly.

Now on 31.10.2018, SE, JLN Circle Narnaul, attended the meeting of enlistment committee and handover his recommendation and affidavit of Sh. Suresh Kumar S/o Sh. Rajender resident of village Lohani Tehsil & Distt. Bhiwani that the Demand Drafts of Tender fees were misplaced but no police report has been lodged in this regard. In addition, SE, JLN Circle, Narnaul vide his office letter No. 2230-31/9G dated: 17.10.2018 has brought out that the Xen, Mahendergarh has recommended the agency may be relaxed from the charges of debarring which were levelled vide his office letter No. 574/19A dt. 12.07.2018 further submitted by SE vide his office letter No. 1519-20/9G dt. 12.07.2018, SE has also recommended to take lenient view on this matter. After detailed discussion and keeping in view of seriousness of the case, the committee has decided that the Jagrambass Co-op L&C Society Ltd. may be directed to deposit the tender fees for both the tenders i.e. pipeline projects of Nolpur Disty. & Hassanpur Disty to the office of Xen, Mahendergarh W/S Division, Narnaul and further taking the lenient view, the agency is debarred for participating in the tender process in Haryana Irrigation & water resources Department for three months from the date issue of order.

**2. Blacklisting case of M/S Shree Balaji Builders and M/S Laxmi Construction Co.:**

The representative of **Shree Balaji Builders**, Sh. Chatter Singh and the representative of **M/S Laxmi Construction Co**, Sh. Sumer Singh had informed the Committee in the previous meeting held on 04.09.2018 vide his written statement that the experience certificate uploaded by his firm was original, without any tempering, as issued by the concerned XEN of the Department and the firm has not made any mistake. Further he has requested not to blacklist the firm. SE, JLN Circle Narnaul and Xen, Narnaul W.S. Division, Narnaul were also present and apprise the committee that the contractor has submitted the experience certificate regarding quantity of works executed during a particular year but when same was got verified from the concerned XEN and it was informed that the experience certificate submitted by the

agency are wrong/false in respect of mentioning of financial year of executed works. Accordingly, he has recommended committee for blacklisting agency.

SE Narnaul has further brought out that during the tender allotment committee meeting held on 23.07.2018. It was decided that SE vigilance Rohtak shall conduct the enquiry regarding wrong/false certificate and submit his report within 15 days. SE, JLN Circle, Narnaul informed the Committee that enquiry in this regard has been entrusted to Xen, Vigilance Division, Rewari & Superintending Engineer, Vigilance Circle, Rohtak & is still under process. After detailed discussion committee has decided that before taking any action on the recommendation of SE Narnaul regarding blacklisting of both the firms, the report of SE vigilance be checked/seen. Accordingly, SE vigilance Circle Rohtak have been requested to finalize his report vide this office letter No. 5435-38/Enlistment/Coordination/2018 dated 18.09.2018, so that further action can be taken up accordingly.

Now, SE, Vigilance Circle, Rohtak vide his letter No. 829-30/1W/Gen dated: 09.10.2018 has submitted his report. He has brought out that

*"Xen, Vigilance Division, Rewari was asked to investigate the matter and submit report. After repeated reminders issued by Xen, Vigilance Division, Rewari and his office, SE, JLN W/S Circle, Narnaul & his Xen supplied the requisite record & on the basis of this, Xen Vigilance Division Rewari investigated the issue & submitted the report vide his office letter No. 1292-93/En(Works) dt. 28.09.2018.*

*From the investigation report, Sh. R.K. Saini, Xen, W/S Division No.2, Rewari, Sh. Labhu Ram the then Xen, Construction Div-7, Hisar and Sh. Dalip Kumar Xen Bond W/S Division Bhiwani were found responsible for the lapses as reported by Xen, Vigilance Division, Rewari in his findings.*

*In addition to above, agencies are also responsible for attaching the wrong experience certificate without confirming them with the quantities and year from their record. Earnest money of the agencies is required to forfeit as per Affidavits given by the agencies."*

Now on 31.10.2018 SE, JLN Circle, Narnaul attended the meeting of Enlistment Committee and after detailed deliberation and thorough on investigation report submitted by SE, Vigilance Circle, Rohtak and Xen, Vigilance Division, Rewari, it has been concluded that besides Sh. R.K. Saini, Xen, W/S Division No.2, Rewari, Sh. Labhu Ram the then Xen, Construction Div-7, Hisar and Sh. Dalip Kumar Xen Bond W/S Division Bhiwani were found responsible for the lapses as reported by Xen, Vigilance Division, Rewari in his findings. But being the class-I agencies i.e. M/S Shree Balaji Builders and M/S Laxmi Construction Co. are also responsible for uploading the wrong certificates as being the class-I contractors, they should have verify the facts from the records of their own office. The enlisted class-I contractors of the department should have to maintain their office and employee a graduate engineer. As such both the agencies could not escape from the responsibility of verification of certificates.

In view of above facts, the Enlistment Committee has decided to debar both the agencies i.e. M/S Shree Balaji Builders and M/S Laxmi Construction Co. for participating in the tender bid of Haryana Irrigation & Water resources for next one year from the date issue of order. As regards to Sh. R.K. Saini, Xen, W/S Division No.2, Rewari, Sh. Labhu Ram the then Xen, Construction Div-7, Hisar and Sh. Dalip Kumar, Xen, Bond W/S Division Bhiwani, the Committee has decided to forward the matter to worthy E-i-C being the Chairman, Tender Allotment Committee for taking necessary action.
