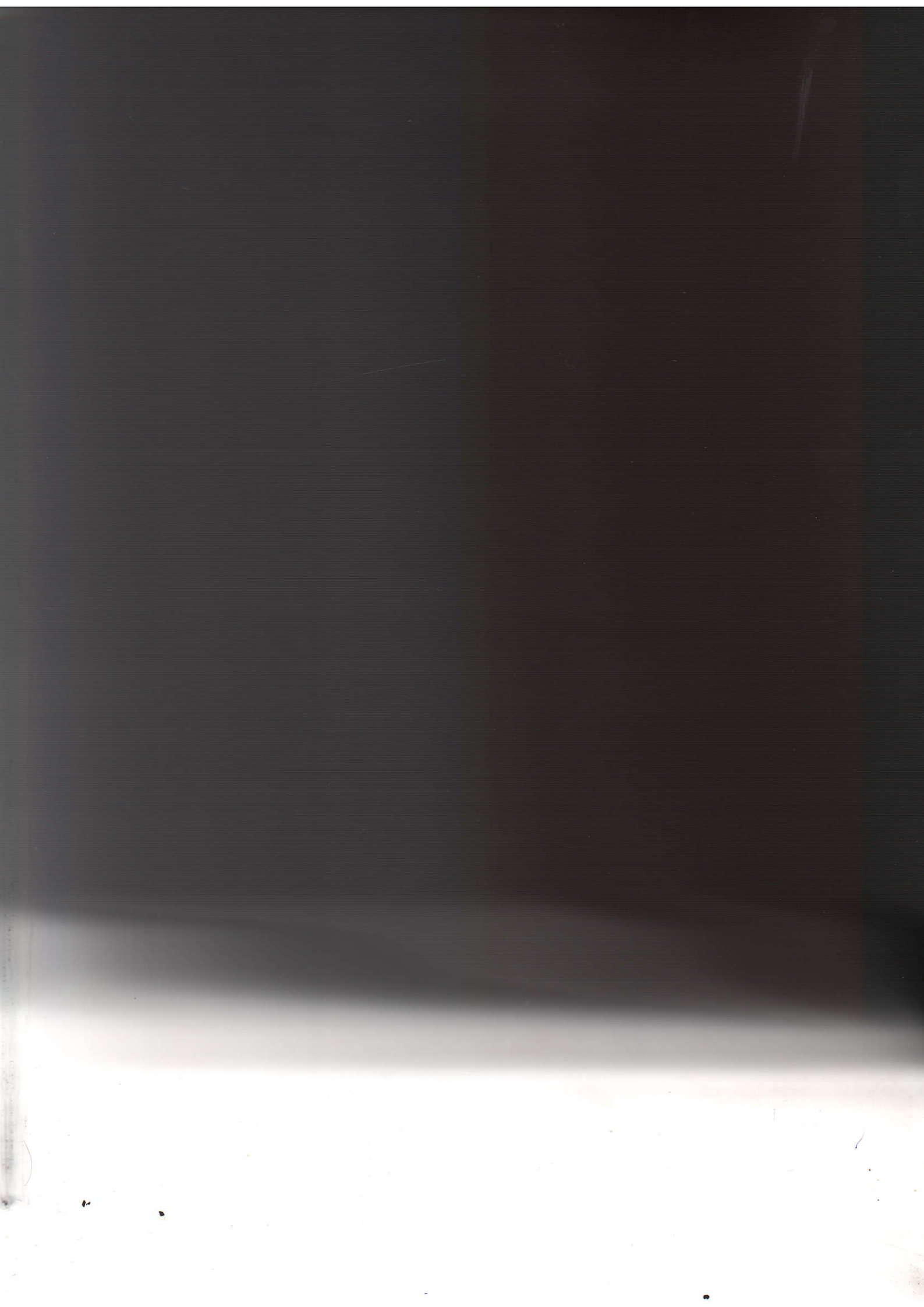
Subject: Case for debarring agency i.e. "The Jodhkan Subham Co-op L&C Society Ltd." for participated in any Bid of Haryana Irrigation Water Resources Department.

In reference to recommendation of SE, BWS Circle, Sirsa vide their office No. 2224/13-AG dated: 29.08.2018 to debar the above said society for non-submission of bid security as per provision in clause 29 of Standard Bid Documents.

An opportunity for personal hearing has been given to the above said agency before the Enlistment Committee on dated: 04.10.2018. During the hearing, the representative of the agency had stated that due to accident of his car he was unable to submit bid security timely. He was only few minutes late to reach the office of Xen, W/S Division Sirsa. He has also stated that the CCTV Footage in the room of Xen, W/S Division Sirsa can be checked.


After hearing the agency, the committee has decided to refer back the case to the concerned SE for verification of the facts narrated by the agency and send report to the committee with comments/recommendation accordingly. In this regard SE, BWS Circle, Sirsa was requested to take the written statement from the concerned agency within 7 days vide this office letter No. 5977-80/Enlistment/Coord./2018 Dated: 16.10.2018.

In reference to above said letter SE, BWS, Sirsa vide his office letter No. 3008/3-A/Tender/Debarring dated: 20.11.2018 has submitted that as stated by the agency, he was only few minutes late to reach the office of Xen, W/S Division Sirsa on dated: 01.08.2018 after closing the tender box due to breakdown of his Vehicle. The facts of the same have also been



verified from the CC TV footage of Sirsa W.S. Division, Sirsa. SE, BWS Circle, Sirsa has further recommended that the case may be taken sympathetically against the agency.


Since the ample time for submission of physical documents was available with the contractor but he moved for submission of documents in the last hours. However, keeping in view of above, the Enlistment Committee has taken lenient view on the above said case and decided to debar the agency i.e. "The Jodhkan Subham Co-op L&C Society Ltd." for participating in the tender bid of Haryana Irrigation & Water resources for next three months i.e. upto 31.03.2019.


