Vide your office U. No. 373/69A dated: 26.03.2018, it has been recommended to blacklist Sh. Avtar Singh, Contractor S/o Sh. Bharat Singh r/o Village Dinod Tehsil & District Bhiwani for the work of construction of D.R. Bridge at RD 41320 Nigana Feeder.

The opportunity to clarify the position was given to Sh. Avtar Singh, Contractor S/o Sh. Bharat Singh r/o Village Dinod Tehsil & District Bhiwani by personal hearing on dated: 30.05.2018. Further vide your office letter No. 941/31A dated: 22.06.2018, you have recommended that the conduct and behavior of Sh. Avtar Singh, Contractor is good and work execution quality is always found good. However, a mistake was committed by him for submitting fake documents. The Contractor has assured that he will not to repeat such mistake in future. He has been recommended that the process of blacklisting may be stopped. An opportunity may be given to Contractor on the ground of his good conduct and behavior and minimum punishment may only be given to Contractor on account of this mistake.

As the enlistment of Sh. Avtar Singh, Contractor has already been expired on 31.03.2018 & not further enlisted in department, so after due deliberation and recommendations of Superintending Engineer, YWS Circle, Bhiwani it was decided by the Committee not to enlist Sh. Avtar Singh, Contractor in Haryana Irrigation & Water Resources Department for next tenure of two years i.e. upto 31.03.2020. The case for enlistment shall be reviewed after taking the performance of the contractor from other departments after 31.03.2020.
